X. Superintendent's Report –Mrs. Garrison stated she would like to recognize Mrs. Bolin and the FFA Chapter for the wonderful FFA Banquet on Friday evening. Senator McCarter attended the banquet and was twitting about it. Thank you to all of the FFA members and Mrs. Bolin for the hard work. It was very nice.

The Primary Election was just held for the Republican Candidate for our Governor. The Governor will give his State of the State Budget Address Wednesday. House Speaker Matt Madigan has proposed a 3% income tax only for the millionaires for the State of Illinois and would earmark this for education.

The State owes \$97,906.75. If the transportation fund are not received by the end of March then money will need to be transferred from the education fund to transportation. The building fund is over budget because of the building issues we have had. If we stay on this path at 82.88 % when we should be 75%, we will need to amend the budget. Mrs. Garrison will be serving on a State Committee and spending time on a way to look outside the box to fix our funding formula. The Pension Reform will be going to court. Mrs. Garrison has asked Kade Gambill to speak on behalf of the students if there is an opportunity to speak on our financial situation in Springfield.
